Volta, Anak Perusahaan Patungan NFCX – MCAS Group dan SiCepat Sukses Ramaikan Indonesia E-Vehicle Expo dan Sekarang Tersedia di Blibli

Jakarta, 04 Nov 2021 – Pameran Indonesia E-Vehicle Expo 2021 yang dilangsungkan oleh Badan Standarisasi Nasional (BSN) di Outdoor Area Ciwalk Mall, Bandung, Jawa Barat pada 2-4 November 2021 telah memasuki penghujung acara. PT. Volta Indonesia Semesta, anak perusahaan patungan PT NFC Indonesia Tbk (IDX: NFCX) – MCAS Group dan SiCepat sebagai salah satu pemain baru di industri kendaraan listrik Indonesia yang juga turut berpartisipasi meramaikan pameran kendaraan listrik Indonesia E-Vehicle Expo 2021 ini, telah sukses mendebutkan kendaraan listrik berteknologi tinggi miliknya. Membawa tiga unit motor listrik Volta tipe 401 beragam warna dan berdesain modern, Volta sukses menyita perhatian pengunjung dengan spesifikasi teknologi motor listrik yang mengusung konsep Sistem Ganti Baterai (SGB).

Willty Awan, Direktur PT. Volta Indonesia Semesta menyampaikan, “Kami melihat antusiasme masyarakat akan kendaraan listrik berkualitas ini bagus. Hal ini dibuktikan dengan mereka yang mengunjungi booth Volta dan menanyakan berbagai hal berkaitan dengan cara kerja motor listrik yang merupakan hal baru bagi kita. Melalui pameran ini, kami harap kedepannya masyarakat bisa lebih aware bahwa dengan beralihnya kita ke kendaraan listrik yang lebih ramah lingkungan, kita juga turut berkontribusi pada keberlangsungan lingkungan yang lebih sehat, tanpa polusi”.

Pemerintah dalam hal ini juga semakin mendukung perkembangan industri kendaraan listrik di Indonesia dengan memberikan berbagai kemudahan. Salah satunya adalah pemberian insentif fiskal dan non-fiskal bagi konsumen BEV, seperti pengenaan Pajak Pertambahan Nilai Barang Mewah (PPnBM) sebesar 0 persen (PP No 74/2021), pajak atas penyerahan hak milik kendaraan bermotor (BBN-KB) sebesar 0 persen untuk KBLBB di Pemprov DKI Jakarta (Pergub No 3/2020).

Melihat dukungan pemerintah yang besar dalam pengembangan ekosistem kendaraan listrik di Indonesia, Volta optimis dapat mendobrak pasar *electric vehicle* Indonesia dengan unit motor listriknya. Melalui tipe 401 yang dipamerkan dalam Indonesia E-Vehicle Expo 2021, Volta menawarkan motor listrik berbodi langsing dan desain modern yang dilengkapi dengan sistem baterai SGB berkapasitas 60V 23A. Dengan bekal ini, Volta 401 mampu melaju hingga jarak 60 km. Selain itu, Volta 401 juga dilengkapi dengan fitur LCD Digital Speedometer, LED Lamp, Remote Alarm, Keyless Ignition System, Double Batteries Slot, hingga USB Charging Port yang memberikan kemudahan bagi pengendara. Tak ketinggalan, unit Volta 401 juga dilengkapi teknologi Internet-of-Things (IoT) yang berguna dalam mengatur penggunaan baterai melalui platform digital yang didukung oleh NFCX.

Jakarta, 04 Nov 2021 – The Indonesia E-Vehicle Expo 2021 exhibition held by the National Standardization Agency (BSN) at the Outdoor Area of Ciwalk Mall, Bandung, West Java on November 2-4, 2021 has entered the end of the event. PT. One of them is the provision of fiscal and non-fiscal incentives for BEV consumers, such as the imposition of a Luxury Goods Value Added Tax (PPnBM) of 0 percent (PP No. 74/2021), a tax on transfer of motor vehicle ownership rights (BBN-KB) of 0 percent. for KBLBB in DKI Jakarta Provincial Government (Pergub No. 3/2020).

Seeing the strong government support in the development of the electric vehicle ecosystem in Indonesia, Volta is optimistic that it can break into the Indonesian electric vehicle market with its electric motor unit. Through the type 401 exhibited at the Indonesia E-Vehicle Expo 2021, Volta offers an electric motor with a slim body and modern design equipped with an SGB battery system with a capacity of 60V 23A. With this provision, the Volta 401 is capable of driving up to a distance of 60 km. In addition, the Volta 401 is also equipped with LCD Digital Speedometer, LED Lamp, Remote Alarm, Keyless Ignition System, Double Batteries Slot, and USB Charging Port features that make it easy for drivers. Not to forget, the Volta 401 unit is also equipped with Internet-of-Things (IoT) technology which is useful in managing battery usage through a digital platform supported by NFCX.
